A member may appoint one or more proxies to attend and vote at the meeting in his stead. A proxy need not be a shareholder of the Company but shall attend the meeting on your behalf in person. Such proxies may only exercise their voting rights in a poll. Any alteration made to this Revised 2024 AGM Proxy Form must be signed by the person who signs it.
- 4. Important: If you wish to vote for any resolution, please **tick** the box marked "**FOR**". If you wish to vote against any resolution, please **tick** the box marked "**AGAINST**". If you wish to abstain from voting in respect of any resolution, please **tick** the box marked "**ABSTAIN**". In the absence of such indication, the proxy will be entitled to cast his votes at his/her discretion. Your proxy will also be entitled to vote or abstain at his/her discretion in respect of any resolution properly put to the meeting other than those referred to in the original notice and supplemental notice of the 2024 AGM. The "**ABSTAIN**" votes will be counted in the calculation of the required majority.
- 5. This Revised 2024 AGM Proxy Form shall be signed by you or your attorney duly authorised in writing or, in the case of a legal person, must be either executed under its common seal or under the hand of its legal representative(s), director(s) or duly authorised attorney(s). If that instrument is signed by an attorney of the shareholder, the power of attorney authorising that attorney to sign or other authorisation documents shall be notarised.
- 6. In the case of joint shareholders, any of such joint shareholders may vote at the meeting, either in person or by proxy, in respect of such shares as if he/she is solely entitled thereto. However, if more than one of such joint shareholders are present at the meeting, in person or by proxy, the vote of the joint shareholder whose name stands first in the register of members of the Company, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint shareholder(s).
- 7. To be valid, this Revised 2024 AGM Proxy Form together with the notarised power of attorney (if any) or other authorisation document (if any) under which it is signed or a notarially certified copy thereof, must be deposited at the Company's H Share Registrar, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong for holders of H Shares not less than 24 hours before the time fixed for holding the meeting or any adjournment thereof.
- 8. To be valid, this Revised 2024 AGM Proxy Form together with the notarised power of attorney (if any) or other authorisation document (if any) under which it is signed or a notarially certified copy thereof, must be delivered to the Company's Board office in the PRC for holders of Domestic Shares, at No. 120 Zizhuyuan Road, Haidian District, Beijing, the PRC, 100097 not less than 24 hours before the time fixed for holding the meeting or any adjournment thereof.
- 9. Completion and return of a Revised 2024 AGM Proxy Form will not preclude a shareholder from attending and voting in person at the meeting or any adjournment thereof if he/she so wishes. In such event, the instrument appointing a proxy shall be deemed to be revoked. Shareholders or their proxies attending the meeting (and any adjournment thereof) shall produce their identity documents.
- 10. All dates and time in this proxy form refer to Hong Kong dates and time.
- 11. The description of the resolutions is by way of summary only. The full text appears in the original notice and the supplementing notice convening the 2024 AGM, which is set out in the Original Circular and Supplemental Circular, respectively.
